**2) SUBMISSION OF APPLICATION:**

Candidates are required to register, apply and upload the necessary documents before submitting their applications **online**. Link to the application portal will be made available in the official website of the office of the Health & Family Welfare Department, Government of Meghalaya. The Applicants are advised to kindly check the website given above for the link for payment of Application fees. Application fees for General candidates is Rs. 460/- (Rupees Four Hundred and Sixty) only and for SC/ST candidates is Rs. 230/- (Rupees Two Hundred and Thirty) only. Applications received through any other mode will not be accepted and will be summarily rejected.

**3) GENERAL INSTRUCTIONS:**

- Applicants are to apply well in advance before the closing date. The last date of application is on or before **12 Midnight of 16<sup>th</sup> February 2024**.
- Candidates need to undergo a Computer Based Testing (CBT) at his/her own expense at Shillong. Venue, date and time for the examination will be intimated in the admit card to be downloaded by the applicant, as well as on the website.
- Selection would be purely based on merit.
- Appointments will be given based on vacancies available.
- Mere appearance of a candidate's name on the list of successful candidates does not necessarily qualify appointment of the candidate.
- Applicants must upload a recent photograph on the space provided in the application.
- Admit Card will be available for download from the website. Applicants are advised to check the website on a frequent basis.
- Selection for the post will be subject to verification of all documents to be brought along in person for physical verification once result is declared and the candidate found successful.

**5) DECISION ON ELIGIBILITY OF CANDIDATES:**

Candidates are advised to carefully go through the eligibility criteria prescribed for each post such as educational qualification, age, physical standards, etc., and satisfy themselves that they are eligible for the posts before applying. **If a candidate does not furnish original certificates to substantiate their educational qualification, his/her candidature will stand cancelled, and the decision will remain final. Candidates who do not manage to fulfill the requisite qualifications as on last date of receipt of application will also not be eligible for the post.**

**Note: Candidates can be rejected at any stage during the recruitment process.**

**6) METHOD OF SELECTION:**

The final selection list against vacancies notified in this advertisement shall be made by the Recruitment Board. The process of selection shall be made based on the marks obtained by the candidates in the Computer Based Testing (CBT) examination plus the additional weightage marks. The distribution of marks is as follows:

- i. **The Computer Based Test will carry 65 marks.**

- ii. **Additional marks for duration of service and experience of doctors/specialists/ dental surgeons working under the Directorate of Health & Family Welfare, Government of Meghalaya are as follows:**
- >5 to 9 years- 10 marks
  - >3 to 5 years- 7 marks
  - >2 to 3 years- 4 marks
  - 1 to 2 years- 2 marks
- iii. **Additional marks against the qualification of the candidate** if he/she has completed Post-Graduate Degrees and Diploma in Medical Science / Dental Surgery are as follows:
- Postgraduate Degree 3 years-10 marks
  - Postgraduate Degree/Diploma 2 years-5 marks
- iv. **Additional marks against a Super-Specialization degree= 5 marks.**
- v. **Additional marks against Rural Posting are as follows:**
- Normalised to 10 marks maximum for duration of 3 years/36 months completed:

7) **DEBARMENT:**

- a. Candidates should make sure of their eligibility for the post applied and that the self-declaration made by them in the format of application regarding their eligibility is correct in all respects. Any candidate providing incorrect information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable TO BE DEBARRED FROM APPEARING FOR ANY OF THE EXAMINATIONS CONDUCTED BY THE BOARD, and summarily their candidature for this recruitment will be rejected.

8) **DECLARATION OF RESULTS:**

- The Result will be declared shortly after completion of Computer Based Testing (CBT) which will be made available on the website/portal/local newspaper and notice board of the Directorate of Health Services (MI), Government of Meghalaya and Office of the District Medical & Health Officer of all Districts. The date for the successful candidates to report to the O/O the Directorate of Health Services (MI) in person with original documents for verification will be notified later. Successful candidates are advised to check the website on a frequent basis.

All doctors appointed under Regulation 3(f) of the Meghalaya Public Service Commission with the department of Health & Family Welfare, Government of Meghalaya must compulsorily apply.
