Application must be submitted online through the Meghalaya Police website. No other forms of application will be entertained. Online Application forms will be made available with effect from **1st April, 2024** onwards. **The entire recruitment process will be conducted as per the Revised Uniform Guidelines for Recruitment of Police Personnel in Meghalaya Police vide OM No. HPL.231/2023/60, dtd. Shillong, the 1st December, 2023. Candidates are advised to check on the Police Departmental website megpolice.gov.in for necessary reference.**
2. **MODE OF APPLICATION : ONLINE.**

8. RECRUITMENT CENTRES

Candidates whose applications are found correct in all respect will have to undergo the Physical Measurement Test (PMT) and Physical Efficiency Test (PET). Before the PMT/PET, Admit Cards will be uploaded at the Meghalaya Police Website. Admit cards with barcodes and names of candidates for post applied and date and venue of recruitment will be given to the applying candidates. Recruitment shall take place at 1st MLP Battalion, Mawiong, East Khasi Hills District, 2nd MLP Battalion, Goeragre, West Garo Hills District, 3rd MLP Battalion, Sahbsein, West Jaintia Hills District, 4th MLP Battalion, Sohpiam, West Khasi Hills District and 5th MLP Battalion, Samanda, East Garo Hills District for which candidates will have to indicate their choice in their online application forms. Dates and venue for PET/Written Test/Personal interview will be duly informed. **If candidates appear in the Tests for a particular post from more than one venue or make an attempt towards that end, his/her candidature will be cancelled forthright for all the venues.**

9. ELIGIBILITY:-

12. PHYSICAL MEASUREMENT TEST (PMT) :

Candidates should download the Admit Card and bring along at the time of appearing for PMT. Candidates who do not meet the standards of Minimum Height Requirement as prescribed will be rejected and further test events of such rejected candidates will not be conducted. The 'rejected' slip generated by the computer system for such rejected candidates will be issued to such candidates.

- (i) **Registration and Authentication of Candidates:** After the Physical Measurement Test, candidates with admit cards will be required to register themselves at the PET registration counters at the venue of recruitment, for biometric data such as Candidates' Finger Prints/Photograph in respect of each candidate which will be captured by the bio-metric application software. The candidates' biometric profile will be verified before the Physical Efficiency Test. Only candidates successfully verified will be allowed for the Physical Efficiency Test (Race).

(ii) **UBSI & AB/UB Group**

5 km race for male and 3 km race for female candidates and Timing Equipment: Each Candidate will be issued with a lockable Radio Frequency Identification (RFID) tag, to be tied to his/her body. The automated timer equipment based on RFID technology will be geared to record start time, finish time and net time of all runners individually. Those who do not complete the race within the minimum prescribed time will be eliminated automatically, only those candidates who have come within the qualifying zone (20 times of the vacancy in the respective category) as per the merit list will be allowed to participate in other subsequent recruitment events. The 5 KM race for male candidates will have to be completed within 24 minutes and the 3 KM race for female candidates will have to be completed within 19 minutes.

The Central Recruitment Board will not be responsible for any injury sustained by a candidate during the 5 Km or 3 Km race.

14. CONDUCT OF WRITTEN EXAMINATION.

AB & UB GROUP

- (i) Only those candidates who have come within the qualifying zone (20 times of the vacancy in the respective category) will be given an Admit Card which can be downloaded from the Meghalaya Police Website. Only those candidates will be allowed to appear at the Written Examination which will be conducted at the time, venue and date to be notified by the Central Recruitment Board. The dates and venues shall be published in local Newspapers and put up on the departmental website.
- (ii) **Written examination for UBSI posts** - shall comprise of 3 papers comprising of (i) **General English** including Précis Writing, Essay Writing, Drafting and English Grammar (Matriculation standard) of **150 Marks**, (ii) **Elementary Mathematics, Reasoning and Basic Science** of **50 Marks** and (iii) **General Knowledge** of **100 marks**. **Total = 300 marks** to be completed in **3 hours**.
- (iii) **Written examination for UB Group** - shall comprise of 3 papers comprising of (i) English Grammar and Usage, (ii) Arithmetic / Elementary Science and (iii) General Knowledge. Each paper shall carry 100 marks. **Total = 300 marks** to be completed in **90 minutes**.
- (iv) **Written examination for AB Group** - shall consist of one paper only, comprising of Elementary and Basic Knowledge of English, Basic Arithmetic and Basic General Awareness. This paper will be of multiple choice / OMR based. **Total = 150 marks** to be completed in **60 minutes**.
- (v) For the **Written examination** in all the posts, a few questions will be set in the regional languages i.e; Khasi and Garo, such questions shall not exceed 5% of the total marks allotted for written examination.

15. Medical Examination.

The Medical Examination will be conducted only in respect of candidates who have been called for the interview for various posts as advertised. No fees to be paid by any candidate for medical examination. Medical Standards: Candidates must not have (i) knocked knees, (ii) flat foot or (iii) squint eyed and they should not have (iv) bad eyesight, colour blindness, varicose vein or piles where it shall be considered a disqualification. They must be in good mental and bodily health. They must be free from any physical deformities. Medical Examination will be carried out as laid down in **O.M HPL. 231/2023/60 dtd. 1st December, 2023 at Annexure – I.**

16. Test for Specialized Trade.

The Central Recruitment Board will conduct specific trade tests of qualifying nature for the selection of drivers etc. Only those candidates who have come within the qualifying zone (20

times of the vacancy in the respective category) as per the merit list will be subjected to these tests.

17. Bonus marks.

The following categories of candidates shall be awarded 5 bonus marks which will be added to their total score: (i) Home Guard Volunteers (ii) Holders of 'B' or 'C' Certificate of the National Cadet Corps (iii) Sports persons who have represented the State at the National Level. All claims for bonus marks should be indicated in the application form and supported with copies of documents for such claims. Original certificates from the competent authority shall be produced by the candidates claiming bonus marks, to verify the eligibility of candidates to these claims. The eligibility of a candidate for Bonus Marks shall be decided by the Interview Board.

18. GENERAL INSTRUCTIONS:

- (i) Helpline numbers for any clarification will be notified through the Meghalaya Police website megpolice.gov.in.
- (ii) The candidates are advised to go to the facilitation centres which will be set up in all the District Headquarters if they have any issues in connection with the online application process.
- (iii) No T.A./D.A. will be admissible to candidates for the journey and stay during any stage of the recruitment.
- (iv) The select lists confers no right to appointment unless the department is satisfied on the suitability of the candidate after a thorough medical examination and such enquiry and verification as may be considered necessary before appointment to the posts. Candidates have to appear in all the stages of recruitment. If a candidate is absent from any stage/ event his/ her candidature will be cancelled.
- (v) The ST/ SC/OST candidates who have taken relaxation in term of age and height cannot claim candidature under Open category.
- (vi) The candidates can be disqualified at any stage of the recruitment process.
- (vii) There shall be no appeal against disqualification.
- (viii) The candidates are advised not to change the mobile number until the recruitment process is over.
- (ix) The candidates are advised to retain their Admit Card with them and keep it properly since it will be required to be produced at a later stage.
- (x) The candidates will be summarily rejected at any stages of recruitment process for not conforming to the official format/ having incomplete information/ wrong information/ incomplete submission of certificate / misrepresentation of facts/ impersonation and necessary legal actions will be initiated in such cases as applicable.



- (xi) A selected candidate will be required to join and work in any District or Unit anywhere in the State of Meghalaya/ anywhere in India. The district from where a candidate gets selected will have nothing to do with his/ her place of posting.
- (xii) Appointed persons shall be entitled to pension benefits as per the pension scheme existing at the time of appointment.
- (xiii) The physical tests are strenuous and as much, it is advisable that only candidates who are in proper medical condition should take the tests. Meghalaya Police will not be liable for any injury or casualty suffered by a candidate during the tests due to any pre-existing medical condition.
- (xiv) Candidates will have to submit copies of the Admit Card and all their documents at the time of personal interview for the purpose of verification at the time of appointment.
- (xv) Fake documents/ false information/ misrepresentation of facts shall lead to rejection when detected at any stage before or after selection/ appointment and shall make the candidature liable to criminal proceedings.
- (xvi) The final appointment after selection is subject to satisfactory Police Verification Report and Final Medical Examination Report as per existing norms. In case Police Verification Report or Final Medical Examination Report is found unsatisfactory, the candidature of such candidates will be rejected outright.
